

3. Vendor must set up between **8:00 a.m. and 9:00 a.m.** on the day of the event. **If late, you will not be admitted.** All vendors must be out of the hall by 4:00 p.m. on the day of the event.
4. All vendors and show personnel **must** park in the assigned parking lot once unloading has been completed. All parking will be directed by staff in the designated areas.
5. For safety, it is important to keep aisles open and free on the flea market floor. Therefore, we ask that all large parts; fenders, hoods, rims, etc., be placed beneath your tables, leaving free the table top for smaller items. Vendors must set up on assigned/approved tables only, or will be asked to move to correct tables. We ask that 4 feet be left between the walls and tables for a walkway to be available. Non-compliance with this rule may result in vendor being asked to leave the flea market.
6. Vendors agree not to tape anything to the floor or walls of the hall.
7. No baked goods or other home cooking is permitted for sale under Ontario law.
8. People bringing autos for the Car Show will be allowed in at 9.00 a.m.
9. Vehicles are not permitted in building without prior approval.

Vending Outside of Main Building

Alternatively, you can vend outside at **\$30.00** per space, on a first come, first serve basis. There is **no pre-registration** for outside vendors ***CASH ONLY***. Space will be allocated to meet your needs by flea market staff upon your arrival. As long as your vehicle and/or tables do not go outside of your assigned space you can vend **AUTO** parts however you wish. No electricity, tables or protection from elements are provided.

2012 Flyer – Business Cards

Approximately 1,000 flyers for next year will be printed prior to this year's event. For the "2012 Flyer", all vendors and clubs are offered the opportunity to have their business card printed on the back of the flyer at a price of **\$25.00**. If you wish to purchase a business card space, **your business card is to be included with payment and must be received by Wednesday, March 16, 2011** due date. If any card space is left over, early participants **may** be offered a second spot. There is space for only 10 business cards to be included on the back of the flyer, therefore space is allocated as cards and payment are received; in other words, on a "first come / first serve" basis. If you don't get a space, your payment will be refunded.

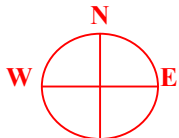
